

Terms and Conditions for Adding Your Visions Federal Credit Union Debit and/or Credit Card to a Digital Wallet Service

Digital Wallet Terms and Conditions:

These Terms and Conditions (the "Terms") apply when you choose to add a Visions Federal Credit Union debit or credit card to a Digital Wallet Service. In these Terms, "you", "your", "their", and "my" refer to the cardholder of the Visions Federal Credit Union Card, and "we," "us," "our," and "Visions Federal Credit Union" refer to the issuer of your Visions Federal Credit Union Card. By agreeing to the Digital Wallet Service Terms and Conditions presented to you during enrollment, you agree to all terms, conditions, and notices contained or referenced in these Terms and you are providing your express consent.

A Digital Wallet Service Is:

A Digital Wallet Service ("Wallet") allows you to add your Visions Federal Credit Union Card(s) to an application using your Mobile Device. Your Visions Federal Credit Union Card number is replaced with a digital number or token. Once added, you understand that you may use your Mobile Device to make payments only where the Digital Wallet is accepted. Visions Federal Credit Union is not a provider of the Digital Wallet and we are not responsible for any failure or inability to perform a transaction using the Digital Wallet. We are only responsible for supplying information securely to the Digital Wallet provider to allow usage of the Visions Federal Credit Union Card in the Digital Wallet. Only Cards that we indicate are eligible can be added to the Digital Wallet.

Eligibility:

Active Visions Federal Credit Union Card accounts that are in good standing are eligible to be added to a Digital Wallet. If your Visions Federal Credit Union Card or any underlying Visions Federal Credit Union account becomes delinquent, is in a negative status or is otherwise maintained in an unsafe manner

as determined by Visions Federal Credit Union in its sole discretion, your Visions Federal Credit Union Card may be removed by Visions Federal Credit Union from the Digital Wallet for continued use.

Relationship to Other Agreements:

You agree that when you add your Visions Federal Credit Union Card to a Digital Wallet service, your Visions Federal Credit Union Card and account will remain subject to the terms and conditions of all existing agreements with Visions Federal Credit Union. You acknowledge that certain message and data rates may apply from your wireless service providers and/or wireless carriers which might impact your use of the Digital Wallet. For example, your mobile service carrier or provider may impose data usage or text charges for your use of or interaction with the Digital Wallet, including downloading the software, receiving or sending text messages, or other use of your mobile device when using the software or other products and services provided by the Digital Wallet. You expressly agree that you are responsible for all such fees, limitations, and restrictions and that We may contact you via your mobile device for any purpose concerning your accounts at Visions Federal Credit Union, including account servicing and collection purposes.

Account Ownership/Accurate Information:

You represent that you are the legal owner of the account and other financial information which may be accessed via the Digital Wallet. You represent and agree that all information you provide in connection with the Digital Wallet is accurate, current, and complete, and that you have the right to provide such information to us for the purpose of operating the Digital Wallet. You agree not to misrepresent your identity or your account information.

You consent to receive electronic communications and disclosures from us in connection with your Visions Federal Credit Union Card and the Digital Wallet. You agree that we can contact you by e-mail at any e-mail address you provide to us in connection with any Visions Federal Credit Union account. It may include contact from companies working on our behalf to service your accounts. You agree to update your contact information with us when it changes.

Measures to Maintain Your Privacy and Security:

Your privacy and the security of your information are important to us. Our <u>Privacy Notice</u> applies to your use of a Digital Wallet. Once you have added your Visions Federal Credit Union Card to a Digital Wallet service, Visions Federal Credit Union is responsible for securely transmitting your information to your

Digital Wallet service provider. Your information is only sent through secure channels. You agree that we may share your information with the Digital Wallet provider, a payment network, and others in order to provide the services you have requested, to make information available to you about your Visions Federal Credit Union Card transactions, and to improve our ability to offer these services. We do not control the privacy and security of your information that may be held by the Digital Wallet provider and that is governed by the privacy policy given to you by the Digital Wallet provider. You agree not to leave your Mobile Device unattended while logged into the Digital Wallet and to log off immediately at the completion of each access by you. You agree not to provide your password or other access information to any other person. If you believe that someone may have unauthorized access to your Mobile Device, you agree to immediately cancel your access to the Digital Wallet associated with the Mobile Device. You agree to provide us with immediate notice in the event you suspect fraud or any unauthorized access to any of your accounts. You agree to comply with all applicable laws, rules and regulations in connection with your Visions Federal Credit Union Card.

You agree to take every precaution to ensure the safety, security and integrity of your account and transactions when using the Digital Wallet.

We may in some cases make individually identifying information available only in the following circumstances: where ordered by a court or other legal body or where it is lawfully permitted or required; where we have agreed to provide information under contracts with vendors and other service providers to make products and services available to our members; or where the member has requested or consents to the disclosure of information. In those cases where we disclose information to outside vendors, we require that they use it for no purposes other than providing previously specified services to our members.

Changes in These Terms and Conditions:

Except as otherwise required by law, Visions Federal Credit Union may in its sole discretion change these terms, and modify or cancel the eligibility to use your Visions Federal Credit Union Card with a Digital Wallet service at any time, without notice. You cannot change these terms but you can terminate them by removing your Visions Federal Credit Union Card(s) from the Digital Wallet. Visions Federal Credit Union reserves the right to refuse any transaction for any reason.

These Terms are governed by federal law and, to the extent that state law applies, the laws of the state that apply to the agreement under which your Visions Federal Credit Union Card is covered. Disputes arising

out of or relating to these Terms will be subject to any dispute resolution procedures in your Cardholder agreement.

Exclusion of Warranties; Limitation of Liability; Indemnification:

YOU EXPRESSLY UNDERSTAND AND AGREE THAT YOUR USE OF A DIGITAL WALLET SERVICE IS AT YOUR SOLE RISK, ANY MATERIAL DOWNLOADED OR OTHERWISE OBTAINED THROUGH THE USE OF THE DIGITAL WALLET IS OBTAINED AT YOUR OWN DISCRETION AND RISK, AND VISIONS FEDERAL CREDIT UNION IS NOT RESPONSIBLE FOR ANY DAMAGE TO YOUR MOBILE DEVICE OR LOSS OF DATA THAT RESULTS FROM THE DOWNLOAD OF ANY SUCH MATERIAL, WHETHER DUE TO ANY COMPUTER VIRUS OR OTHERWISE. VISIONS FEDERAL CREDIT UNION MAKES NO REPRESENTATION OR WARRANTY AS TO THE COMPLETENESS, ACCURACY, RELIABILITY, OR CURRENCY OF ANY INFORMATION OR DATA THAT YOU OBTAIN THROUGH THE USE OF A DIGITAL WALLET. EXCEPT AS OTHERWISE PROVIDED BY LAW, IN NO EVENT SHALL VISIONS FEDERAL CREDIT UNION, ITS AFFILIATES, AGENTS, EMPLOYEES OR REPRESENTATIVES BE LIABLE FOR DEATH, PERSONAL INJURY, PROPERTY DAMAGE, OR ANY INCIDENTAL, SPECIAL, INDIRECT, PUNITIVE, EXEMPLARY OR CONSEQUENTIAL DAMAGES WHATSOEVER, INCLUDING, WITHOUT LIMITATION, DAMAGES FOR LOSS OF PROFITS, LOSS OR DAMAGE TO DATA, BUSINESS INTERUPTION OR ANY OTHER COMMERCIAL OR FINANCIAL DAMAGES, LOST REVENUES, OR OTHER LOSSESS OF ANY KIND, ARISING OUT OF OR IN ANY WAY RELATED TO YOUR USE OR INABILITY TO USE ANY DIGITAL WALLET, HOWEVER CAUSED, REGARDLESS OF THE THEORY OF LIABILITY (CONTRACT, TORT OR OTHERWISE) AND EVEN IF WE HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. YOU AGREE TO HOLD VISIONS FCU AND ITS VENDORS HARMLESS FROM ANY CLAIM, ACTION OR LOSS DUE TO YOUR USE OF THE DIGITAL WALLET. THIS SECTION SHALL SURVIVE ANY TERMINATION OF THESE TERMS AND CONDITIONS.
